The scheme prioritizes talent development and offers complete education to individuals, allowing them to refine their craft and expertise.

## Stipend Support

#### Tool Kit Assistance

To facilitate the artisans' work, this scheme provides a monetary amount of Rs. 15,000 to purchase advanced tools and devices.

## Eligibility Criteria

•You must be an artisan or craftsman operating in any of the 18 trades before anything else.

- Carpenter, Boat Maker, Armourer, Blacksmith, Hammer and Tool Kit Maker, Locksmith, Goldsmith, Potter, Sculptor, stone carver / Stone breaker, Cobbler, Footwear artisan, Mason, Basket Maker/ Basket Waver: Mat maker/ Coir Weaver/ Broom stick maker and etc ...
- In addition, you have to be older than 18, and none of your family participants can be employed by the government.
- The scheme's advantages are only to be had by one member of the family.
